Notice is hereby given that the Board of Directors of Chimney Hill Municipal Utility District of Harris County, Texas, will hold a **regular meeting**, open to the public, on **WEDNESDAY, 8 JUNE 2016**, at **6:30 p.m.** at the **Chimney Hill/Camfield Joint Wastewater Treatment Plant, 13450 Traders Village Drive, Houston, Texas**, outside the boundaries of the District, for the purposes of considering and acting upon the following matters:

1. Consider comments and questions from District residents;
2. Minutes of Board of Directors meetings of 27 April, 6 May, and 11 May 2016;
3. Security Patrol Report, including Contract Activity Statistical Report;
4. Solid Waste Collection Report (contract expires 4/30/2018; 60-day notice), including replacement of carts;
5. Review Strategic Plan (pending projects);
6. Report on maintenance of storm water drainage channel at WWTP (Stuckey's Contract Services, LP), including review proposals for:
  - (a) repairs of sinkholes; and
  - (b) replacement of fencing;
7. Discuss meeting presentation technology and authorize actions deemed necessary, including:
  - (a) status of purchase of new monitor, mini-computer, and related components for WWTP Building;
  - (b) disposition of used equipment;
8. Engineer's Report, including:
  - (a) discuss status of proposed replacement of WWTP blowers (including proposed fine air conversion) and authorize actions deemed necessary;
  - (b) status of contract for rehabilitation of lift stations including SCADA Integration Phase 2 (McDonald Municipal & Industrial) and authorize actions deemed necessary;
  - (c) status of contract for auxiliary generator for Water Plant No. 2 (McDonald Municipal & Industrial) and authorize actions deemed necessary;
  - (d) status of contract for installation of electronic water meters throughout the District (Mueller Systems) and authorize actions deemed necessary;

- (e) status of plans and specifications for proposed SCADA Integration Phase 1 (Water Plants);
  - (f) discuss possible televised inspection of sanitary sewer lines;
  - (g) review cost estimate for recoating of WWTP clarifier components;
  - (h) status of application to TCEQ for renewal of wastewater discharge permit (due 11/1/16) and authorize actions deemed necessary;
  - (i) review status of GIS system;
  - (j) requests for service;
  - (k) requests for annexation and service;
9. Operator's Report, including:
- (a) status of repairs to Water Well No. 2 (Layne Christensen Co.), including status of insurance claim;
  - (b) status of repairs to sanitary sewer manholes;
  - (c) monthly operations report;
  - (d) repairs to District's facilities, and authorize actions deemed necessary;
  - (e) status of City of Houston water supply, including Monthly Allotment (currently 13,860,000 gallons);
  - (f) sanitary sewer overflows, permit violations, and/or insurance claims;
  - (g) authorize action against delinquent accounts, including termination of service;
  - (h) report on inflow and infiltration in sanitary sewer system and authorize actions deemed necessary;

11. Executive session pursuant to V.T.C.A., Government Code, Chapter 551, to discuss matters related to pending or contemplated litigation, real estate transactions, and/or security matters;
12. Action on matters discussed in executive session;
13. Schedule future meetings as required; and
