



TO: THE BOARD OF DIRECTORS OF CHIMNEY HILL MUNICIPAL UTILITY DISTRICT OF HARRIS COUNTY, TEXAS, AND TO ALL OTHER INTERESTED PERSONS:

Notice is hereby given that the Board of Directors of Chimney Hill Municipal Utility District of Harris County, Texas, will hold a **regular meeting**, open to the public, on **WEDNESDAY, 13 JUNE 2018, at 6:30 p.m.** at the **Chimney Hill/Camfield Joint Wastewater Treatment Plant, 13450 Traders Village Drive, Houston, Texas**, outside the boundaries of the District, for the purposes of considering and acting upon the following matters:

1. Consider comments and questions from District residents;
2. Minutes of Board of Directors meeting of 9 May 2018;
3. Security Patrol Report (Harris County Sheriff's Department), including review Contract Activity Statistical Report;
4. Solid Waste Collection Report (contract expires 4/30/21; 60-day notice);
5. Report on maintenance of storm water drainage channel at WWTP (Stuckey's Contract Services, LP) and authorize actions deemed necessary, including approval of Consent to Assumption of Contract (Stuckey's, LLC);
6. Review Strategic Plan (pending projects);
7. Discuss renewal of alarm permits for security systems;
8. Annual review of District's Emergency Response Plan;
9. Discuss proposed walking trail project (Chimney Hill Community Association, Inc.) and authorize actions deemed necessary;
10. Engineer's Report, including:
  - (a) status of plans and specifications for proposed replacement of WWTP blowers (including proposed fine air conversion) and authorize actions deemed necessary;
  - (b) status of contract for extension of utility lines to serve SRP-H NW Logistics Center tract (RAC Industries, LLC) and authorize actions deemed necessary;
  - (c) status of SCADA Integration Phase 1 (Water Plants);
  - (d) discuss infrastructure improvements on Eldridge Parkway at Firebrick Drive (Harris County) and authorize actions deemed necessary, including relocation of District utilities;
  - (e) status of 5-year Capital Improvements Plan, including possible sale of bonds;
  - (f) requests for service;
  - (g) requests for annexation and service;

11. Operator's Report, including:
  - (a) monthly operations report;
  - (b) status of City of Houston water supply, including Monthly Allotment (currently 13,860,000 gallons);
  - (c) repairs to District's facilities, and authorize actions deemed necessary;
  - (d) sanitary sewer overflows, permit violations, and/or insurance claims;
  - (e) review cost estimate for modification to lift pumps;
  - (f) authorize action against delinquent accounts, including termination of service;
12. Attorney's Report, including:
  - (a) discuss possible request from Westbrook Lakes HOA (dredging of detention pond, maintenance of tract between Chimney Hill and Westbrook Lakes subdivisions);
  - (b) status of annexation of 26.1-acre tract on Eldridge Parkway (SRP-H NW Logistics Center, L.P.);
13. Executive session pursuant to V.T.C.A., Government Code, Chapter 551, to discuss matters related to pending or contemplated litigation, real estate transactions, and/or security matters;
14. Action on matters discussed in executive session;
15. Schedule future meetings as required; and
16. Discuss items to be placed on future meeting agendas.
